

What are online payments?

It is a service that allows Teem users to receive credit card payments, and allow their customers to pay them using Mada, Apple Pay, Mastercard and Visa. All received payments will then be automatically transferred into the Teem user's bank account.

Are there any commissions or fees for activating the service?

Commissions made to the payment gateway are applicable, and they amount to 1.9% + 1 SAR for Mada and 2.8% + 1 SAR for credit card. As for SNB users (formerly SAMBA and NCB), there will be no additional fees to activate the feature.

How long does it take to activate online payments?

Activating online payments takes 24 -72 hours.
